Call to Order

- **Dr. Salek, Vice Chair**, called the Arizona Substance Abuse Partnership Council meeting to order at **1:04 PM**. Thirteen members, four staff members, four guests, and five members of the public were present.

Welcome/Introductions

- **Dr. Salek, Vice Chair**, welcomed everyone and asked all members to introduce themselves.
- **Dr. Salek, Vice Chair**, conducted a roll call for members in attendance.

Approval of Minutes

- **Dr. Salek, Vice Chair**, declared reaching a quorum and requested a review of the **December 4, 2024** meeting minutes, before requesting a motion to approve the meeting minutes as drafted.
 - **Council Member Sargent** motioned to accept the **December 04, 2024** minutes.
 - **Council Member Bloom** seconded the motion.
 - The motion passed with no dissenting votes at **1:10 PM**. [Download a copy of the final minutes from our website.](#)

Addressing Substance Use Through Systemic and Trauma-Informed Frameworks

- **Dr. Sara Salek, Vice Chair**, introduced Erica Chavez of [Touchstone Health Services](#).
- Erica Charvez shared a presentation regarding the interconnected nature of mental health trauma, addressing substance use prevention from a systems lens. **Ms. Chavez** opened with an overview of the definition of trauma, including the lasting impact of trauma and the benefits of a wrap-around approach to care.
- **Ms. Chavez** then provided an overview of Touchstone's trauma-informed approach to care, including its [School-Based Services \(SBS\) Program](#), which impacts over 900 students in over 60 schools across the valley. She also reviewed the different modalities used by Touchstone care teams to address substance use through a mental health lens.
- **Ms. Chavez** closed by providing information regarding the prevention services available through Touchstone's CARE Grant and [CARE Coalition](#) including young adult programs, teacher training programs, positive parenting programs, and upcoming professional development opportunities for education, mental health, and school health professionals.
- **Dr. Salek, Vice Chair**, opened up the floor to the ASAP council for questions.
- **Dr Salek, Vice Chair**, asked **Ms. Chavez** about common trends in schools after COVID-19 closures. **Ms. Chavez** shared some of the mental health, crisis response, and substance use trends.
- **Dr. Salek, Vice Chair**, asked **Ms. Chavez** if most schools have access to Naloxone. **Ms. Chavez** stated that many of their school partners have access.

Evidence-Based Care for Substance-Exposed Newborns & Their Families

- **Dr. Salek, Vice Chair**, introduced **Shauna Anderson** of [Hushabye Nursery](#).
- **Shauna Anderson** shared an overview of Hushabye Nursery and their mission to positively impact substance-exposed newborns and their families. Ms. Anderson thanked the GOYFF for supporting programming over the years.
- **Ms. Anderson** shared information regarding the Hushabye cooperative model of support with healthcare providers, prenatal care, aftercare services, and outpatient support. Ms. Anderson shared strategies for cross-sector collaboration and building partnerships with child welfare agencies to support family preservation and family unification of babies with their mothers including the Hushabye Opioid Pregnancy Preparation & Empowerment (HOPPE) Program.
- **Ms. Anderson** shared information about the unique wrap-around withdrawal treatment for substance-exposed infants at Hushabye including transfer for care, the various types of therapies and medical intervention provided, and an overview of the economic impact of providing services in the community versus a hospital intensive care setting.
- **Dr. Salek, Vice Chair**, opened up the floor to the ASAP Council for questions.
- **Council Member Sargent** thanked **Ms. Anderson** and asked about data collected after families are discharged from services.
- **Council Member Cantelme** thanked **Ms. Anderson** for her services via the chat.
- **Council Representative Jones** asked about the service delivery model (in person or virtual) and the geographic service area.
- **Council Member Breed** expressed thanks via chat for Hushabye Services and shared that Adult Probation has visited Hushabye and is impressed with their model.

Data Visualization Dashboard for Substance Use Prevention*

- **Dr. Salek, Vice Chair**, introduced **Council Representative Matt Bileski** of the [Arizona Criminal Justice Commission](#) and provided a brief background and purpose of the Data Visualization Dashboard.
- **Council Representative Bileski** shared the history and the progress of the Data Visualization Dashboard. He shared the different sources of the data, the response sizes of the data received, and the different ways to view the data.
- **Council Representative Bileski** then provided an overview of four different dashboard views and explained how the data was broken down within each subcategory. (Arizona Youth Survey (AYS) Data, Substance Use Disorder (SUD) Diagnosis Totals, SUD Treatment Rates & Totals, Foster Care Status)
- **Council Member Sargent** asked **Council Representative Bileski** where the data will be housed. **Council Representative Bileski** stated that it will be available for public access via the [GOYFF website](#) after final internal leadership approval.
- **GOYFF Staff Luchsinger** asked about any trends that Mr. Bileski and their team have observed in the data. **Council Representative Bileski** shared changes in overall use and shifts in gender distribution but recommended connecting with the rest of the team from Arizona State University for a deeper dive into trend analysis.

- **Dr. Salek, Vice Chair**, suggested that Dr. Domino from Arizona State University, one of the partners on this project, receive an invitation to the next ASAP Meeting to provide additional information regarding the young adult use trends.
- **Council Member Bloom** asked if mental health data could be or will be included in future dashboards. **Council Representative Bileski** shared that the AYS does not currently collect mental health data and shared other avenues for data partnerships they are pursuing.
 - **Dr. Salek, Vice Chair**, requested a motion from the council to approve the public release and posting of the Data Visualization Dashboard for Substance Use Prevention to the GOYFF Website.
 - **Council Member Bloom** motioned to approve the **Data Visualization Dashboard for Substance Use Prevention** for public release and posting to the GOYFF Website. Materials not available for public view at this time.
 - **Council Member Mertz** seconded the motion.
 - The motion passed with no dissenting votes at **1:55 PM**.

Upcoming Events & Announcements

- **Alfreda Moore, GOYFF Staff**, provided information about upcoming events, resource releases, and upcoming awareness months related to substance use/misuse.
 - **Evidence-Based Drug Education Training Opportunity** from Midwest Counterdrug Training Center held on April 21- 24, 2025, 8 AM-5 PM in Chandler, AZ. This 28-hour training course is designed to provide an in-depth understanding of substance misuse. Rooted in scientific evidence, this course explores various drugs, their effects on the human body and behavior, and their broader social implications.
