**CALL TO ORDER**

- **Denise Beagley, Chair**, called the Arizona Parents Commission on Drug Education and Prevention meeting to order at **10:03 AM** with **five** members and **four** staff/guests present.

**WELCOME/INTRODUCTIONS**

- **Denise Beagley, Chair**, welcomed everyone and asked members to introduce themselves.

**APPROVAL OF MINUTES**

- With the quorum met, **Denise Beagley, Chair**, requested a review of the **January 15, 2025**, meeting minutes before requesting a motion to approve them as drafted.
  - **Delvyn Crawford** moved to approve the meeting minutes as drafted.
  - **Ariadne Weber** seconded the motion.
- **Denise Beagley, Chair**, asked for a discussion of the minutes, and no members requested amendments.
- **Denise Beagley, Chair**, called a vote, and at **10:07 AM**, the motion to approve the meeting minutes as drafted passed with no dissenting votes.

**SUPPORT FOR PREGNANT WOMEN EXPERIENCING HOMELESSNESS | MAGGIE'S PLACE, PHOENIX, AZ**

- **Denise Beagley, Chair**, welcomed and introduced **Laura Magruder**, chief executive officer of [Maggie's Place](#).
- **Ms. Magruder** highlighted the wide range of services available to participants, including housing, direct support services, parenting and child enrichment programs, health and wellness initiatives, and educational programming.

- **Ms. Magruder** detailed how staff support women through motivational interviewing, goal setting, attending Arizona Department of Child Safety (DCS) court hearings, organizing birthday celebrations for their children, and providing essential items like clothing and food. She also noted that over 30 monthly classes cover financial literacy and parenting topics.
- **Ms. Magruder** emphasized that Maggie's Place is a certified Trauma-Informed Care organization. She explained that many of the women they serve face ongoing challenges such as substance use disorders, trafficking, violence, and homelessness.
- **Ms. Magruder** added that Maggie's Place is staffed 24 hours a day, 7 days a week by trained AmeriCorps members, ensuring women have continuous, around-the-clock support.
- **Denise Beagley, Chair**, thanked **Ms. Magruder** for the presentation and asked commission members if they had any questions or comments.
- **Mr. Crawford** asked what violations could prevent women from continuing in the program.
  - **Ms. Magruder** clarified that violations will result in a woman being unable to live in Maggie's Place housing; however, this will not exclude her from participating in other programs or events. Examples of violations include drug use, possession of a weapon, or acts of violence.
- **Mr. Crawford** inquired about how Maggie's Place triages potential clients and supports those not admitted.
  - **Ms. Magruder** explained that Maggie's Place has an intake process to evaluate the needs of each potential client. If they cannot accommodate someone, they provide referrals to other agencies. She mentioned that the facility offers 34 available beds.
- **Ms. Weber** asked whether clients receive case management to support long-term goals and how long they can stay in the apartments.
  - **Ms. Magruder** stated that women can start the program and stay in housing until their child turns one year old. After clients transition to an apartment, they may remain for up to one year following reunification with their child.
- **Ms. Werchan** asked if clients were allowed to keep their cell phones.
  - **Ms. Magruder** confirmed that clients are permitted to have and keep their phones.
- **Ms. Braham** expressed gratitude for the strong partnership between Maggie's Place and Community Medical Services.

#### NURSE-FAMILY PARTNERSHIP PROGRAM | CASA DE LOS NIÑOS, TUCSON, AZ

- **Denise Beagley, Chair**, welcomed and introduced **Bridget Werchan**, Nurse Home Visitor at [Casa de los Niños](#).
- **Ms. Werchan** presented an overview of Casa de los Niños' 52-year history, emphasizing the agency's mission to prevent child abuse and neglect. She highlighted the diverse range of services and programs offered, noting the significant success of The Kelly Early Education Center in reducing barriers for parents. Additionally, she outlined services available for youth and young adults, including home visitation, parenting programs, and behavioral health services.
- **Ms. Werchan** explained that the Nurse-Family Partnership program, established in 2011, aims to improve prenatal care, enhance child health and development education, and provide system support to strengthen family economic stability. She emphasized that the Nurse-Family Partnership is an internationally recognized, evidence-based program. All staff members hold Bachelor of Science in Nursing degrees and are trained in the Nurse-Family Partnership model.
- **Denise Beagley, Chair**, thanked **Ms. Werchan** for the presentation and asked commission members if they had any questions or comments.
- **Mr. Crawford** asked whether individuals or families share their stories.

- **Ms. Werchan** shared that many clients have spoken at various events, including addressing the state legislature at the Capitol. She also mentioned that a recent [news article](#) about Casa de los Niños expanding its Nurse-Family Partnership program highlighted client testimonials. The expansion now supports mothers at any stage of pregnancy, lifting previous restrictions that limited services to first-time mothers before their 28th week.
- **Deputy Chief of Staff Lopes** asked how Casa de los Niños adapts to meet culturally specific needs, particularly for Indigenous populations.
  - **Ms. Werchan** emphasized the organization's commitment to cultural sensitivity and competency. She described how staff thoughtfully converse about beliefs and customs, particularly regarding pregnancy and motherhood, to ensure respectful and supportive care.
