#### Arizona Service Enterprise Initiative

Closing out the second year of the Volunteer Generation Fund, which provides the funding for this initiative. The closing will require some data collection, which staff are excited to share at the Commission meeting in December.

Priorities for the Annual State Service Plan were discussed.
