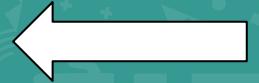

The HIDTA mission is to disrupt the market for illegal drugs in the United States by assisting Federal, state, local, and tribal law enforcement participating in the HIDTA program to dismantle and disrupt drug trafficking organizations, with emphasis on drug trafficking regions that have harmful effects on other areas of the United States.

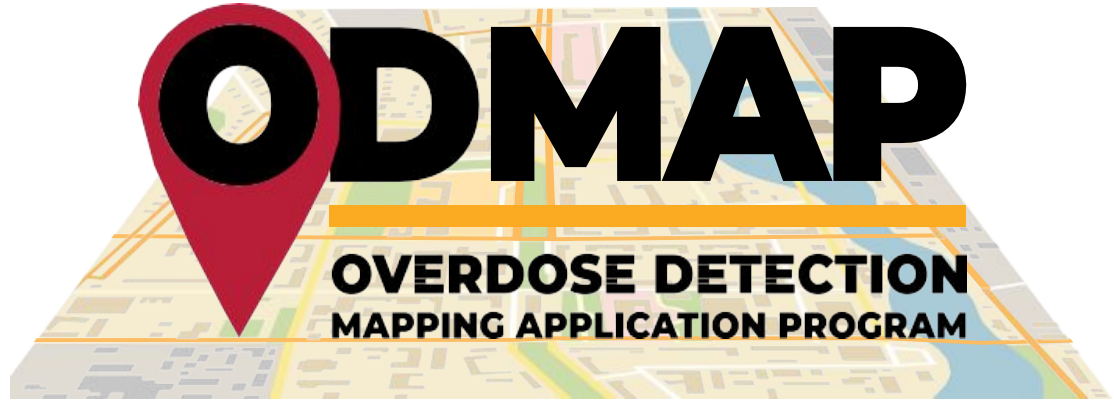

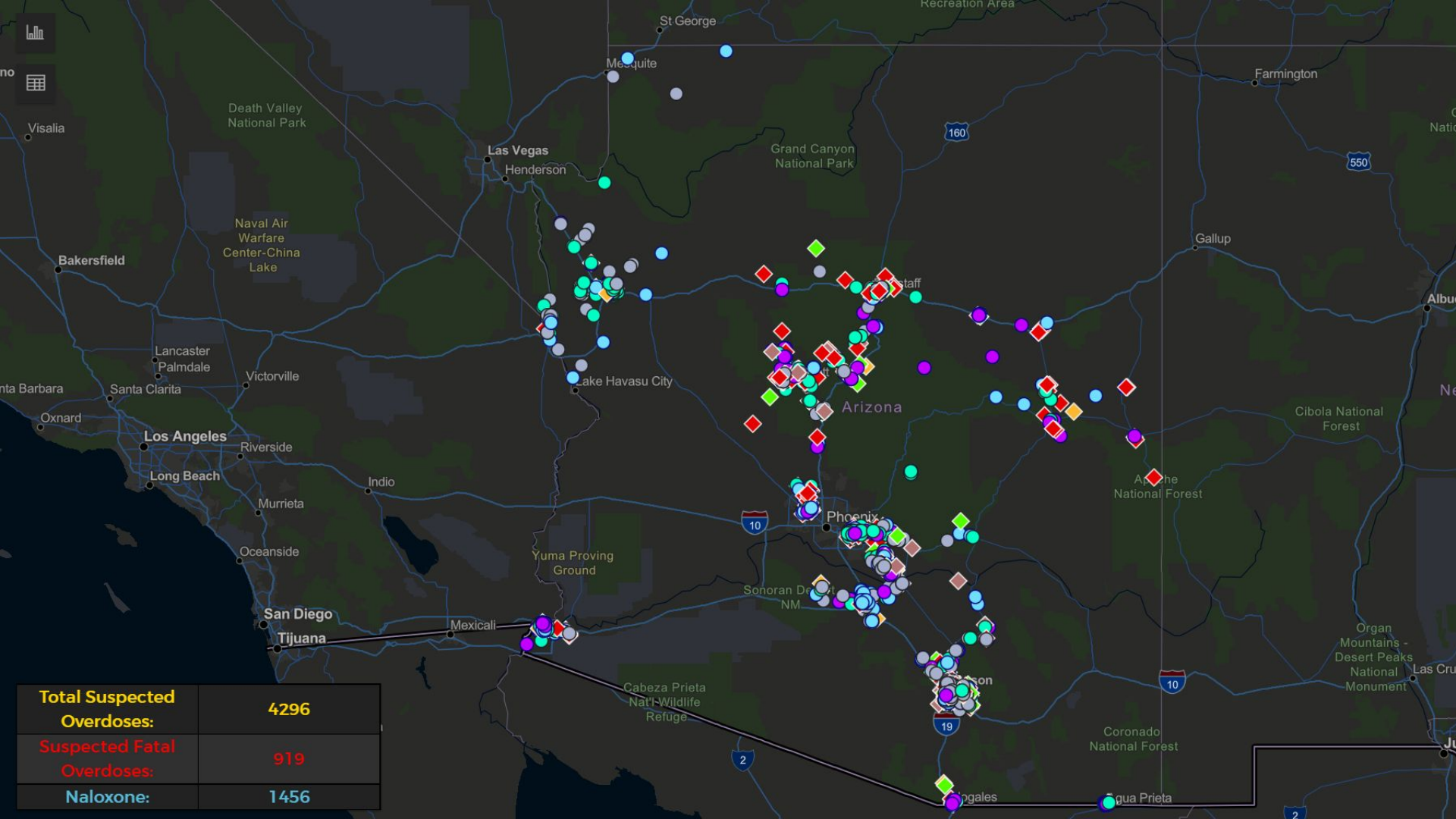

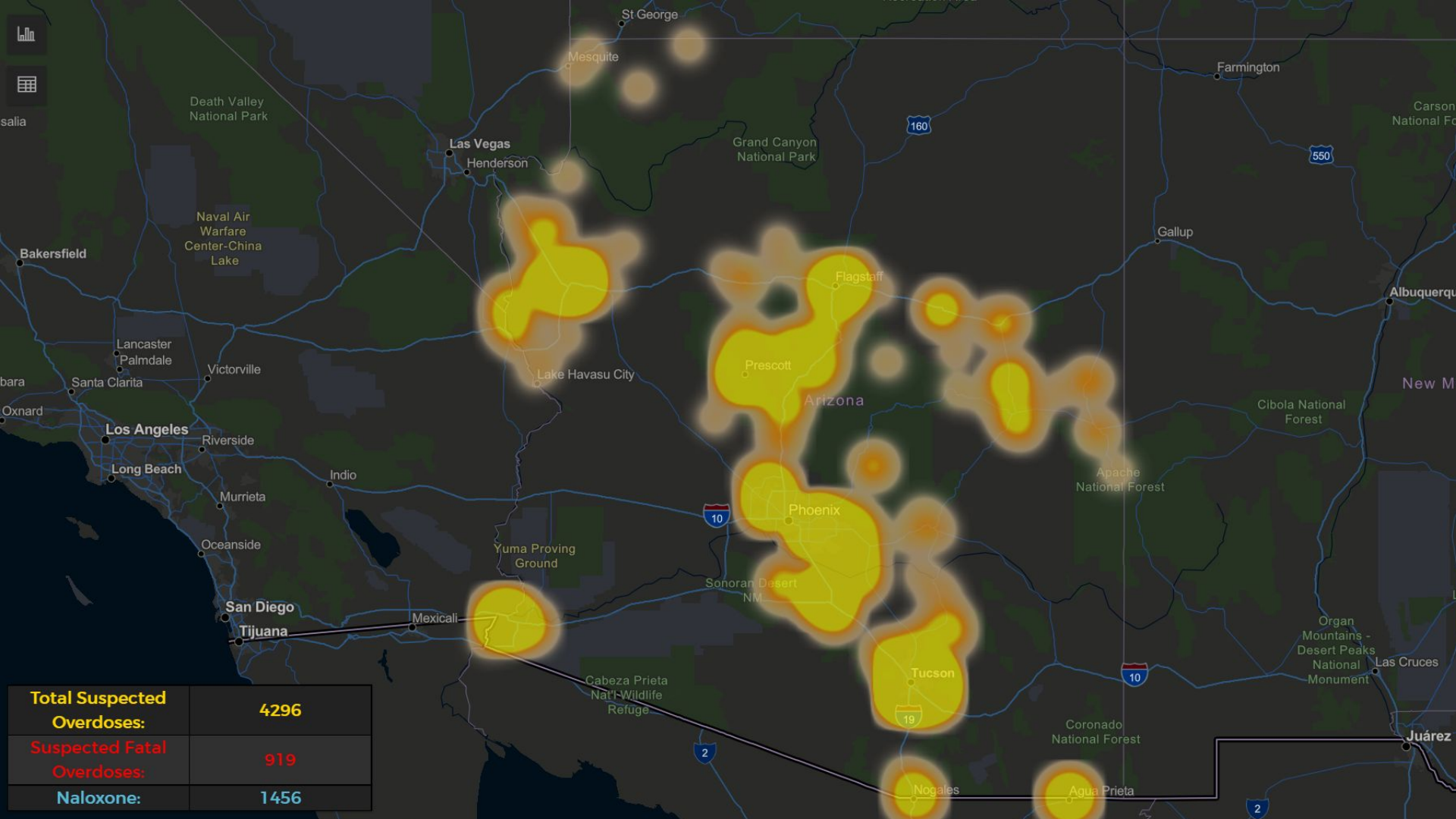

ARIZONA HIDTA NALOXONE LEAVE BEHIND PROGRAM



- Arizona HIDTA partnered with the Arizona Department of Health Services to develop a Naloxone Leave Behind Program.
- Brochures are non-stigmatizing and provide information to resources directly within the communities and counties for which they are designed.
- Includes information on the Good Samaritan Law and how to administer Naloxone safely as needed.

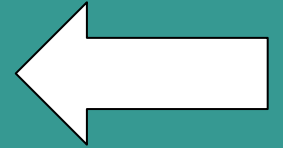
