Victims of Crime Act (VOCA) Assistance Funds

The purpose of the Victims of Crime Act (VOCA) Assistance Funds is to support agency staff that provides direct services to victims of crime in Arizona.

Services are defined as those efforts that:

- (1) respond to the emotional and physical needs of crime victims;
- (2) assist primary and secondary victims of crime to stabilize their lives after victimization;
- (3) assist victims to understand and participate in the criminal justice system; and
- (4) provide victims of crime with a measure of safety and security such as boarding up broken windows and replacing or repairing locks.

A <u>crime victim</u> is anyone of any age who has suffered financial, physical, sexual or emotional harm as a result of the commission of a crime. Types of victimization include but are not limited to:

Allowable costs can include:

Salaries/Wages and Employee Related Expenses for direct service personnel such as advocates, therapists, counselors, case managers, etc.

Contracts for Professional Services Translation/Interpreters Printing Brochures
Computers, Printers, Monitors, etc. Advanced Technologies Equipment and Furniture
Training and Related Travel Costs Website Design and Maintenance Membership Dues

Purchasing/Leasing of Vehicles Cell Phones Billboards

Operating Costs such as prorated share of rent and utilities, office supplies, telephones, internet, etc. **Client (Emergency Financial) Assistance** such as relocation assistance, security deposits, reasonable moving expenses, transitional housing costs, etc.
